Two tracks

Law and Commerce Track

Focus on the study of legal and regulatory responses to business, commercial or financial activities.




Law and Technology Track

Focus on the study of legal and regulatory responses to technology developments.

- Tracks are open to students working on topics involving the 3-way interaction of law, commerce and technology.
- Determine and declare tracks NO later than the beginning of Year 2.

Fees and Financial Assistance

SMU Incentive Package in Interdisciplinary PhD Programmes

SMU YPHSL will provide support for the purchase of research-related items in broad categories approved by OPGRP, and strongly encourage PhD students to go for an overseas exchange in their 4th year.

SMU Incentive Package will provide travel support for overseas / summary school exchange, and "DART" equivalent discretionary research fund. Students can apply for travel support for up to one overseas exchange in their candidature. Students can also be awarded research fund in each year, but no roll-over of funds allowed.

Admission Criteria

- At least a <u>Bachelor's degree</u> in law or related disciplines such as <u>Business</u>, <u>Finance</u>, <u>Economics</u>, <u>Computer Science or Political Science</u>, from a reputable undergraduate or postgraduate programme with good academic performance.
- A Master's degree is recommended BUT not required.
- One writing sample (such as a published paper and/or undergraduate report).
- Good GRE results [1].
- Good TOEFL or IELTS scores [2].

Waive for graduates of SMU, NUS, NTU, SUTD, SIT and SUSS. Within 5 years before the proposed date of admission. May submit your online application without the GRE score. SMU's GRE institution code is 2861.

University education was **NOT** English. Within 2 years before the proposed date of admission. SMU's institution code for TOEFL is 9014.
